Dear FOIA Officer:

Under the Freedom of Information Act, 5 U.S.C. § 552, as amended (the "FOIA"), I am requesting a copy of records generated by the CIA in its probe into the July 17, 1996 TWA Flight 800 tragedy. Specifically, I seek copies of records that were produced in the FOIA litigation *Stalcup v. CIA*, USDC MA Case 11-11250. Please produce these records in electronic format, or PDF.

More specifically, I seek records indentified in two cover-letters accompanying productions. Copies of these transmittal letters are attached. The first such letter, dated March 30, 20 12, identifies its enclosures:

Enclosed at Tab A is one DVD copy of the CIA produced video. Enclosed at Tab B are 49 documents that can be released in their entirety. Enclosed at Tab C are 89 documents that can be released in segregable form with deletions made on the basis of FOIA exemptions (b)(1), (b)(3), (b)(5), (b)(6) and/or (b)(7)(c).

I seek the documents identified as appearing under Tabs B and C, and do not seek the DVD.

The CIA's first letter appearing in the *Vaughn* index in the captioned case, dated May 28, 2010, states that the Agency "received an earlier FOIA request for records on the same subject..." and enclosed "25 previously released" documents, totaling "234 pages." The CIA refers in this letter to the case of *Lahr v. National Transp. Safety Bd.* 453 F. Supp.2d 1153 (C.D. Cal. 2006). I do not seek the records transmitted with this May 2010 letter.

The cover-letter accompanying the other relevant production, dated October 24, 2012, states, "[e]nclosed are 14 documents that can be released in segregable form with deletions made on the basis of FOIA exemptions (b)(1), (b)(3), (b)(6), (b)(7)(c), and or (b)(7)(e)." It is these 14 documents that I seek.

Please note that this request is limited to records that were not previously produced in *Lahr v. National Transp. Safety Bd. et al.* Thus, if not unduly burdensome, please exclude from the scope of this FOIA Request records that were produced by the CIA in the *Lahr* litigation even if such records are otherwise identified as having been produced by the CIA in its letters of March 30, 2012, and October 24, 2012, in the captioned matter.

If there are any fees for searching for, reviewing, or copying the records, please notify me before processing, if the amount is to exceed fifty dollars. However, inasmuch as this request is limited to already made disclosures referenced in the Agency's two attached letters (March 30, 20l2 and October 24, 2012), I suggest that there should be no search or review fees. Kindly produce these records in electronic format. *See* e-FOIA amendment 5 U.S.C. § 552 (a)(3)(B), as amended, requiring Agency to "provide the record in any form or format requested . . . if the record is readily reproducible by the agency in that form or format." *See generally* FOIA Update Vol. XVII, No. 4, 1996.
